I further agree to indemnify and hold harmless Safe Harbor Rescue Mission and their officers, agents, servants, and employees from any and all claims resulting from injuries, damages and losses sustained by me or arising out of, connected with, or in any way associated with the activities of Safe Harbor Rescue Mission.

In the event of an emergency, I authorize officials of Safe Harbor Rescue Mission to secure from any licensed hospital, physician, and/or medical personnel any treatment deemed necessary for my immediate care and agree that I will be responsible for payment of any and all medical services.
